ORDER

WHEREAS In terms of Section 14(1) of the NCTE Act, 1993 Mohamed Sathak Trust, Chennel - 600 034, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE in the name of Mohammed Sathak Dasthagir Teacher Training College, Inside Collectorate Complex, Pattinamkathan (P.O.), Ramanathapuram --623503, Tamilnadu for seeking grant of recognition for conducting B.Ed Course of one year duration on 01.10.2010.

AND WHEREAS the application was processed and deficiency letter was issued to the institution on 06.01,2011. The institution submitted its written representation on 08.03,2011, which was considered by SRC in its 202nd meeting held on 14th -15th March 2011 and the Committee decided to cause inspection.

AND WHEREAS inspection of the institution was carried out on 8.04.2011. SRC considered the VT report in its 204th meeting held on 27th-28th April, 2011 and decided to issue show cause notice. Accordingly notice was issued to the institution on 1,06,2011. The institution submitted its replies on 14.06.2011, 27.6.2011 and 5.7.2011.

AND WHEREAS the SRC in its 208th meeting held on 13-14 July 2011 considered the reply of the institution for issuance of letter of intent prior to grant of recognition under clause 7(9) of the NCTE regulation. Accordingly, LOI was issued to the institution on 19.07.2011. The institution submitted reply on 30.07.2011. The SRC in its 209th meeting held on 31st July 2011 considered the reply to LOI and on careful perusal of the original file of the Institution and approved stall profiles from the affiliating body, submitted by the institution in response to the letter of Intent, the Regional Committee decided that Formal Recognition be granted to B.Ed., course of one year duration with an annual intake of 100 (One hundred only) students subject to submission of valld/renewed minority status certificate & rectification of deficiencles in staff list, if any.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to Mohammed Sathak Dasthagir Teacher Training College, Inside Collectorate Complex, Pattinanikathan (P.O.), Ramanathapuram - 623503, Tamilnadu for conducting B.Ed Course of one year duration with an annual intake of 100 (Hundred) students from the academid session 2011-2012 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject, to fulfillment of the following conditions:

1. The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.

IV. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

- The institution shall declare themselves as minority trust and minority institution proposed to be established
- VI. The institution/Management shall produce valid minority certificate from the notified authority of the respective State Government on or before 31st March, 2012, failing which, the institutions shall be de-recognized automatically without any further notice and that such institutions shall make no further admission thereafter.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- (i) Copy of the Application Form
- (ii) Land and Building Particulars
- (lii) Staff Profile
- (iv) Recognition letter
- (v) Information for having fulfilled the norms & standard and other required conditions.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
